WFL Endangered Stream Live Talk Radio for Animal Protection presents, "Concrete Evidence", in the interest of justice for elephants. This special program brings exposure to the hidden cruelties and business practices behind zoo walls. An expert guest panel including Mariana Tosca, Catherine Doyle, Adam Roberts, David Casselman and Sheryl Greene will spotlight the serious risk/health factors involved for elephants confined to zoos and circuses with a look into wild capture, poaching and habitat destruction. Updates regarding the ongoing law suit against the City of Los Angeles will be discussed along with a focused look at the Billy, their lone remaining elephant.

The sneak preview will air live on Saturday, May 2nd, 2009 from 3PM -5PM (PST)/ 6PM-8PM (EST) with the Premiere release airing on Sunday, May 10th at 4PM PST/7PM EST. The WFL Endangered Stream Live chat room will be open during both presentations.

Mariana Tosca is the Spokesperson for Voice for the Animals Foundation, serves as Chief Animal Welfare Advisor to Rep. Dennis Kucinich (D-Ohio) and is a lifelong animal & environmental advocate and vegan. Mariana lectures on issues of Animal Protection and is also the International Spokesperson for In Defense of Animals and is a member of the Advisory Board for Born Free USA and Elephant Voices.

Catherine Doyle is the Elephant Welfare Specialist for In Defense of Animals and Founder of LA Alliance for Elephants. Catherine is an elephant expert and avid defender of the rights of elephants to be free from forced captivity, torture, and isolation.

Adam Roberts is Senior Vice President of Born Free USA and serves on the Board of Directors of the Species Survival Network a global coalition working on wildlife trade under the Convention on International Trade in Endangered Species of Wild Fauna and Flora. Adam is also a Board Member of Humane USA and he recently helped launch the Global Federation of Animal Sanctuaries.

David Casselman is the senior trial partner in the Los Angeles law firm of Wasserman, Comden & Casselman. David is a long time friend of animals of all kinds, having provided millions of dollars of pro bono legal services to animals and those who try to protect them. Mr. Casselman is also the Founder of the Cambodia Wildlife Sanctuary.
